

Order No. R-37/2023 of the Rector of Lublin University of Technology dated 4 May 2023.

concerning fees paid by master's degree students conducted in a foreign language at Lublin University of Technology for educational services provided in the academic year 2023/2024

Pursuant to Article 23 and Article 79(1)(2), (3) and (4) and (3) of the Act of 20 July 2018, Act on Higher Education and Science (consolidated text in Journal of Laws of 2023, item 742), I h e r e b y o r d e r as follows:

§ 1

- Students undertaking and completing a master's degree programme conducted in a foreign language shall pay fees for services involving the possibility of taking the classes indicated in the plan and programme within particular semesters, in the amount specified in the Appendix to this Order.
- 2. As part of the fee referred to in Section 1, students referred to in Section 1 may participate in courses offered by the University in a foreign language which is different from the Polish language and the language of instruction.

§ 2

Besides the fee referred to in § 1(1) at Lublin University of Technology students referred to in § 1(1) are required to pay fees for educational services related to:

- 1) repeating full-time courses due to unsatisfactory academic performance;
- 2) participation in courses not included in the programme.

§ 3

- 1. The fee for the repetition of a failed course due to unsatisfactory academic performance in a full-time master's degree programme conducted in a foreign language amounts to PLN 180 for each ECTS credit allocated to the course.
- 2. The fee for the repetition of a failed "diploma thesis" course, carried out under readmission to a degree programme, is set at PLN 200 per one ECTS credit allocated to that course.
- 3. The fee for student participation in courses not included in the study programme is set at PLN 200 per one ECTS point allocated to these courses.
- 4. The fee for the repetition of a course for which no ECTS credits are allocated is PLN 200.

- 1. In cases of a student's difficult financial situation, the Rector may, at the written, justified request of the student, exempt the student from fees in part or in full.
- 2. In justified cases, at the student's request, the Rector may extend the fee payment deadline or agree to pay the fee in instalments.

§ 5

Supervision of the implementation of this Order is entrusted to the Vice-Rector for Student Affairs.

§ 6

The Order shall enter into force on the date of signature.
