The personal data of participants in the "Erasmus Postcard from LUT" Competition for students visiting Lublin University of Technology under the Erasmus+ programme, to the extent provided in the application form, will be processed for the purpose of organising, promoting, and conducting the Competition, publishing information about the Competition winners on the Lublin University of Technology website and in the media in connection with promoting the University's educational activities, as well as for archiving purposes and for accountability required by Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR) on the protection of personal data.
4. Personal data provided by a representative of the University are collected on the basis of consent provided in accordance with Article 6(1)(a) of the GDPR, for the purposes of organising and conducting the Competition and publishing information about the Competition winner.
5. Personal data will be stored in accordance with the requirements of the Act of 14 July 1983 on the National Archival Resource and Archives (consolidated text Dz. U. [Journal of Laws] of 2020, item 164, as amended) for the period specified in these provisions.
6. Recipients of personal data may include users of media, websites, and social media platforms belonging to Lublin University of Technology in connection with the publication of information about the Competition winner.
7. Persons whose personal data are processed by the Data Controller have the right to:
  - 1) access their data and receive a copy thereof;
  - 2) request the rectification of their data if it is incorrect or outdated, and also request the removal of their data where processing is not necessary to fulfil a legal obligation or to exercise public authority;
  - 3) request the restriction of the processing of personal data;
  - 4) object to the processing of data where the processing is not based on the data subject's consent;
  - 5) lodge a complaint with the President of the Personal Data Protection Office (UODO) (address: Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw).
