3. The personal data of participants in the Competition titled “Erasmus at LUT? YES!” for incoming students as part of the Erasmus+ programme at the Lublin University of Technology in the scope arising from the submission form shall be processed for the purpose of organising, promoting, and proceeding with the Competition, publishing information on Competition winners on the website of the Lublin University of Technology, and in the media in relation to promoting the educational activities of the University, and for archiving and accountability purposes required under Regulation (EU) 2016/679 of the European Parliament and of the Council on personal data protection, hereinafter referred to as the GDPR.
4. Personal data, provided by the University’s representative, will be collected pursuant to a consent given under Article 6 (1)(a) of the GDPR, for the purpose of organising and proceeding with the Competition and publishing information about the winner of the Competition.
5. The personal data shall be stored in accordance with the requirements stipulated in the Act of 14 July 1983 on National Archival Resources and Archives (consolidated text, Dz. U. [Journal of Laws] of 2020, Item 164, as amended) for a term set out in the said legal regulations.
6. The recipients of personal data may include the users of mass media and social media accounts held by the Lublin University of Technology in connection with publishing information about the competition winner.
7. The data subjects whose data are processed by the Controller have the right to:
 - 1) request access to their data and receive a copy thereof;
 - 2) request rectification (correction) of their data, if they are inaccurate or outdated, and the right to request their erasure if the data are not processed for compliance with a legal obligation or in the exercise of official authority vested in the Controller;
 - 3) request restriction of data processing;
 - 4) object to processing where it is not based on the data subject's consent to the processing;
 - 5) lodge a complaint with the President of the Personal Data Protection Office (to the address of the Personal Data Protection Office [Urząd Ochrony Danych Osobowych], ul. Stawki 2, 00-193 Warszawa).
8. The provision of data is voluntary, but necessary to allow the Controller to organise the Competition, notify the winner about the award of prizes and process data in relation to the educational and informational activities being conducted.
9. The person whose personal data are processed by the Lublin University of Technology in relation to the Competition is entitled to withdraw his/her consent to processing at

any time to the extent of the consent granted. The withdrawal of the consent will not affect the lawfulness of the processing before its withdrawal.

10. The Controller does not process the Competition participants' personal data by automated means.
