

Terms and Conditions of the “Erasmus Postcard from LUT” Competition

§ 1. General provisions

1. The Organiser of the Competition “Erasmus Postcard from LUT” (hereinafter: the *Competition*) is Lublin University of Technology (hereinafter: the *Organiser*).
2. The Competition Coordinator is the Vice-Rector for Student Affairs at Lublin University of Technology.
3. The Competition is open to students of legal age visiting the Lublin University of Technology under the Erasmus+ programme (hereinafter: the *Participant*).

§ 2. Competition aims

The aim of the Competition is to prepare a postcard from Erasmus in the form of a photo – portrait or group photo, which:

- 1) promotes active participation at Lublin University of Technology among students arriving under the Erasmus+ programme;
- 2) promotes Lublin University of Technology or the city of Lublin as a destination under the Erasmus+ programme;
- 3) can be used in electronic promotional and informational materials of Lublin University of Technology.

§ 3. Competition procedure

1. Participants are expected to submit:
 - 1) an electronic photograph in PNG, JPEG or HEIC format, with a resolution of 2480x1400 pixels;
 - 2) a completed application form, which constitutes Appendix No. 1 to these Terms and Conditions;
 - 3) consent to personal data processing for the purpose of announcing the Competition results, which constitutes Appendix No. 2 to these Terms and Conditions;
 - 4) a copyright declaration, which constitutes Appendix No. 3 to these Terms and Conditions.to the email address: erasmus@pollub.pl by 13 March 2026, 2:00 p.m.
2. Only photographs for which copyright has not been transferred to third parties may be submitted to the Competition.
3. Each Participant may submit only one entry.
4. Photographs containing content that is contrary to the legal order of the Republic of Poland, offensive or abusive content, content infringing the copyrights of third parties, as well as erotic, obscene, ridiculing, indecent content, or content violating generally accepted moral standards, personal dignity (including on religious, ethnic, or racial grounds), or photographs that do not meet the requirements set out in these Terms and Conditions, shall not be eligible to participate in the Competition.

§ 4.
Competition Committee

1. To conduct the Competition, the Vice-Rector for Student Affairs at Lublin University of Technology appoints a Competition Committee (hereinafter: the *Committee*) composed of:
 - 1) Head of the Office of International Education as the Chair;
 - 2) two employees of the Office of International Education.
2. The Committee exercises supervision over the conduct of the Competition and, in particular:
 - 1) assesses whether the Participant and the submitted photograph meet the formal requirements set out in these Terms and Conditions;
 - 2) oversees the proper conduct of the Competition.
3. Decisions regarding the Competition and organizational matters are made by the Chair of the Committee.
4. If the Committee finds that the Terms and Conditions or the general principles referred to in § 3(4) have been violated, the Committee has the right to cancel the participation of the given entry in the Competition.

§ 5.
Announcement of Competition results and prizes

1. Photographs complying with the rules of these Terms and Conditions along with a voting form will be posted on the website of the Office of International Education (hereinafter: *BKM*) – www.bkm.pollub.pl. The voting process will result in selecting one photograph which receives the highest number of votes.
2. Each student and employee of Lublin University of Technology who has an email address in the domain pollub.edu.pl or pollub.pl may cast one vote. Only one vote may be cast from each email address.
3. The results of the Competition will be announced on 16 April 2026 at 12:00 noon during Erasmus Day – an event organised on the campus of Lublin University of Technology promoting the cultures of countries of students participating in the exchange programme.
4. The winner of the Competition will receive an in-kind prize.
5. Upon collection of the prize, the winner is obliged to submit a declaration of receipt, constituting Appendix No. 4 to these Terms and Conditions.

§ 6.
Personal data protection, copyright

1. The winner shall not be entitled to any other claims for any reason, in particular regarding the transfer of rights to the photograph submitted in the Competition, against the Organiser or any third parties.
2. The Organiser reserves the right that, upon awarding the prize, it acquires ownership of the physical copy of and the economic copyright to the winning photograph in all known fields of use, with the right to transfer them to third parties.

3. Participation in the Competition is equivalent to giving consent to the processing of personal data for the purpose of organising and conducting the Competition. Full information on personal data processing is contained in Appendix No. 5 to these Terms and Conditions.
4. Competition Participants consent to the storage and processing of their personal data pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). The legal basis for personal data processing is consent for the processing of data for specified purposes pursuant to Article 6(1)(a) GDPR. Failure to provide consent will result in the inability to participate in the Competition.

§ 7. Final provisions

1. Participation in the Competition constitutes acceptance of the Competition rules and these Terms and Conditions.
2. The Organiser reserves the right to:
 - 1) amend the dates specified in these Terms and Conditions;
 - 2) cancel the Competition without giving any reason;
 - 3) not declare a winner of the Competition.
3. In matters not regulated by these Terms and Conditions and in case of disputes, the decision shall be made by the Competition Coordinator.
